**ORDER:**

The Secretary, TSWREIS has submitted proposals seeking approval of the Government for appointment of (567) Teachers/Special Teachers (63 Male Teachers and 504 Female Teachers, including Librarians and Staff Nurses), who are qualified as per Service Rules and were appointed on contract basis during 2007, in the 36 DPIP & RPRP Girls Schools, on regular basis now against sanctioned posts, including the posts sanctioned vide G.O. 10<sup>th</sup> read above.

Government, after careful examination of the matter, hereby permit the Board of Governors and Secretary, TSWREIS to take necessary action to appoint (567) Teachers/Special Teachers against the regular sanctioned posts in appropriate categories in the 36 DPIP & RPRP Schools, after due verification of the qualifications and other procedural requirements under the service rules and also keeping in view the court orders in this regard.

3. The above appointments shall be with effect from the date of issue of appointment orders by the competent authority and subject to court orders in this regard.
