IN THE COURT OF HON'BLE FIRST ADDL JUDICIAL FIRST CLASS MAGISTRATE AT HANAMKONDA HONORED SIR,
Occurred on 09-10-2024 at around 5 P.M, at Flat No.B-403 PGR Lakeview Towers, Waddepally, Hanamkonda and reported on 22-10-2024 at 21;10 hours, by the complainant X, wherein the accused Ravi Kumar, circle inspector of police, Warangal who is residing on the same floor in Flat No.B-403 and found the victim girl "Y" was speaking with her classmate/friend Trinadh in the corridor adjoining their residence flat No.B-405, he went to the spot where victim was talking with her friend and questioned victim her friend. Then she replied that he was a classmate and friend whereupon the said accused Ravi Kumar told her to send the boy away and come to his residence (B-403). Due to fear she went accused residence. Taking this advantage the accused Ravi Kumar caught victim arm and attempted to drag her towards his bedroom. At that moment, victim resisted him. Thereafter, said Ravi Kumar touched over her body. At the said time Ravi Kumar was alone in his residence. Later accused threatened her not to disclose to parents and forcibly took her phone number and verified the same by giving a missed call from his official phone.
